6. Evaluation of Bids

Technical Evaluation

The scoring model given in the previous section shall be followed for evaluating the technical bids of each bidder. The relevant documents for evaluation shall be provided by the bidders, in case any document is not submitted for scoring, it shall be treated as zero.

To become eligible for short listing, the bidder must secure at least Fifty percent marks in each attribute and Sixty percent marks in aggregate in the scoring model. The IISER Tirupati, however, reserves the right to restrict the list of short listed agencies out of technically qualified agencies to any number deemed suitable by it but minimum three in case the technically qualified bidders are more than three.

Financial Evaluation

The Financial Bid of those Bidders who have been found to be technically eligible will be opened. The Financial bids of ineligible bidders will not be opened.

The Financial Bids shall be opened in the presence of representatives of technically eligible Bidders, who may like to be present. **Indian Institute of Science Education and Research Tirupati** shall inform the date, place and time for opening of the Financial Bid.

Evaluation and Comparison of Bids

The Evaluation and comparison of Bids will be based on the total amount quoted by the bidder (whose Financial bids are opened).

The order will be placed on the L1 Bidder.
