- 30 numbers of columns comprise of minimum of $4 \mathrm{~g}, 50$ numbers with a minimum of $12 \mathrm{~g}, 20$ numbers with a minimum of $24 \mathrm{~g}, 20$ numbers with a minimum of 40 g and 20 numbers with a minimum of 100 g and 10 numbers with a minimum of 350 g prepacked refillable columns and 5 numbers of C18 columns of different sample loading capacity to be supplied along with the system. Equivalent specs to these quantities are acceptable.
- Criteria of leak detection feature may be considered OPTIONAL.
