IISERT/PUR/0101/20.</i></b>
2.	The Bidder should have Annual Turnover of minimum 20 crores every year for the last 3 consecutive years and Audited Balance sheet must be submitted along with a statement of account by C.A. (Chartered Accountant).	<b><i>The OEM/Principal shall also guarantee &amp; certify in the same letter that all tender terms and conditions viz. Quality of product offered, Genuineness of product offered, Performance Bank Guarantee, Security Deposit, EMD, Tender fee, Solvency Certificate &amp; Delivery timelines etc. will be strictly adhered to by their authorized representative, whom the OEM/Principal is nominating to represent for this particular on behalf of the OEM/Principal.”</i></b>  <b>However, such representatives will not be eligible for any MSME/NSIC exemption.</b>
