### **ESSENTIAL FEATURES OF REQUIRED ACCOMMODATION**

- 1. The capacity of Building should accommodate around 200 students.
- 2. The distance between IISER Tirupati Campus and hiring building should be preferably within 5KM.
- 3. The hostel building is required to accommodate 2 or 3 students per room, as decided by the institute.
- 4. The accommodation should have well ventilated and clean rooms with habitable condition and hygienic environment.
- 5. Sufficient number of bathrooms and toilets must be provided in good, clear and hygienic condition.
- 6. The room should be furnished with adequate lights, fans and preferably with a wardrobe.
- 7. Electricity and Potable Water for drinking, bathing and cooking, must be available round the clock.
- 8. All necessary sanitary and water supply installations connections must be provided in the facility.
- 9. Electrical installations and fittings like power plugs, switches, charging points etc. must be in place.
- 10. Emergency power backup / generator facility would be preferable.
- 11. The building should preferably have suitable provision and adequate space for running Mess for students.
- 12. The Service provider/ Building owner must provide document of Sanctioned Electricity I

# HIRING OF BUILDING FOR HOSTEL ACCOMMODATION TERMS & CONDITIONS

- 1. Indian Institute of Science Education & Research, Tirupati (at present running at transit campus) is desirous of hiring suitable buildings as Hostel for 200 no. of students located around IISER Tirupati preferably within 5 KM radius on entirely temporary basis initially for a period of six months on monthly rental basis which can be extendable for further period of six months. The hostel building is required to accommodate 2-3 students per room as decided by the institute.
- 2. No commercial activity other than the Hostel will be carried out on the leased premises.
- 3. Selected party shall be required to execute a lease agreement containing detailed terms & conditions with **IISER Tirupati**, in accordance with the provisions of the law applicable.
- 4. The Agreement shall be signed for a period of Six Months, which may be extended for further period on mutually agreed terms and conditions upon satisfactory performance.
- 5. Building offered must be free from all encumbrances, claims and legal disputes etc.
- 6. The electricity and water supply lines / connection shall be provided by the owner at his own cost and expenses. However, **IISER Tirupati** shall pay all running charges with respect to electric power and water charges of the said premises during the lease period on the basis of actual consumption.
- 7. Building should be preferably three storey including ground floor, if more than 3 stories then lift must be available in working condition with all the safety features.
- 8. **IISER Tirupati** reserves the right to consider/reject any such proposal without assigning any reason. In case of rejection of application, the decision of competent authority will be final and binding and the party shall not be entitled to any compensation whatsoever for non issue of work.
- 9. The decision of IISER Tirupati will be final in case of any dispute arising in the implementation of the terms of the contract.
- 10. Service Maintenance charge should be mentioned, if any. IISER Tirupati will not pay any Holding Tax or dues for hired building. The building should have been properly constructed as per the approved safety plans.
- 11. All property tax, all municipality tax, local taxes will be included in the rental and details of such viz. Property tax, all Municipal Taxes and other Local Taxes being levied and paid in respect of the accommodation offered should be clearly indicated.

- 12. Proper Fire safety arrangements are mandatory.
- 13. Any other salient aspect of the building which the party may like to mention.
- 14. The agreement for hiring of buildings/accommodation shall come into force immediately after it is executed and shall remain in force for the period agreed upon.
- 15. **PAYMENT:** IISER Tirupati will only be liable to pay fixed monthly charge, electricity and water supply on the basis of actual consumption and fixed monthly Service Maintenance charge if any. Payment will be made by cheque/RTGS/NEFT on submission of bill every month.
- 16. If the building is found unsuitable to accommodate 200 students, then the rent will be paid only for the actual no. of students accommodated in the building on pro-rata basis.
- 17. IISER Tirupati will not be liable to pay any charge for the normal wear and tear of fittings and fixtures in the Building premises.
- 18. The lessor shall be solely responsible for obtaining any permissions/licences etc. from any local authority for leasing out the premises for the aforesaid purpose.
- 19. The building/s shall comply with all fire safety norms.
- 20. **TERMINATION**: The Agreement may be terminated by giving one-month notice by either party of the Agreement. However, during such notice period the buildings along with all ongoing facilities shall remain in the possession of IISER Tirupati.

- 3. Eligible and competent Service Providers, building / Flat owners, Agencies are requested to submit their offer in prescribed application form under two bid systems in the standard formats prescribed in the Tender documents, displayed as **TECHNICAL BID** Annexure I & **FINANCIAL BID** as Annexure II
- 4. - 5. All the requisite information should be filled in prescribed form with relevant information and attaching required documents that are clearly readable. All the pages of the document should be signed by authorized signatory.
- 6. PREPRATION OF BIDS: The offer/bid should be prepared in two bid systems (i.e.) in prescribed format as Technical bid and financial bid. The technical bid should consist of all technical details along with commercial terms and conditions and supporting documents. Financial bid should indicate only the commercial terms & conditions

Technical Bid: Technical Bid should contain the following:

I. **Technical Bid**: Technical Bid should contain the company Profile on printed letter head of the Bidder's firm in prescribed TENDER FORM as TECHNICAL BID FOR PRE-QUALIFICATION in ANNEXURE "I" along with other required information /documents etc.



Technical Bid shall contain papers regarding:

- a. Filled up application for TECHNICAL BID FOR PRE-QUALIFICATION prescribed as **Annexure-"I"** duly signed on each page by the authorized signatory of the bidder as a mark of acceptance of all conditions of the EOI.
- b. Ownership document of the building or Agreement Copy if the premise is on lease.
- c. Document for sanctioned Electricity load.
- d. Income Tax /PAN Registration Certificates
- e. All other requisite documents in support of Bid
- II. **Financial Bid:** Financial bid should contain Providers/ Building owners/Agencies name and **monthly Rental** including all charges to be quoted by bidder. The Financial proposal shall not include any conditions to it and any such conditional financial proposal shall be rejected summarily. The Financial has to be submitted in the format as prescribed TENDER FORM as FINANCIAL BID **ANNEXURE "II".**
- III. These envelopes should be securely sealed separately and clearly marked as "Envelope No:1-Technical Bid" and "Envelope No:2-Financial Bid" respectively.
- IV. The envelopes containing the Technical bid, financial bid, shall be placed into an outer envelope and sealed.
