The tender mentions 1000 students, but is this the overall college strength or the expected strength for each canteen?</p> <p>Allocation of Student Strength: Is there a fixed allocation of student strength for each canteen setup? For example, a specific number for North Indian canteen and a separate number for South Indian canteen?</p>	<p>The institute doesn't guarantee a minimum number of diners per meal. This canteen will operate similarly to the pay-and-eat system in restaurants but at subsidized prices. With the present campus population of around 1000 students and approximately 200 other diners (staff, faculty, and day scholars) which shall gradually increase slowly, the system completely relies on the discretion of the diners, without guaranteeing any vendor any business. There's no compulsory allocation or expected strength for each canteen due to this approach. But the vendors are supposed to provide all items mentioned in the menu at all times similar to that of restaurant business without fail.</p>
2	<p>Existing Canteen Facilities: Are there any other canteen facilities within the college premises apart from the mentioned North and South Indian setups?</p>	<p>There is one small kiosk for refreshments and hot & cold beverages in the campus.</p>
