4. The applicant will be responsible for the authenticity of information submitted/ documents and photographs. It is the responsibility of the candidate to assess his / her own eligibility for the post(s) for which he/she is appearing in accordance with this advertisement. Based on the recommendations of the Screening Committee, the Project Leader may restrict the number of candidates for the interview to a reasonable limit after taking into consideration the qualifications and experience over and above the minimum prescribed in the advertisement.
