2	Insertion of Clause 10.4 after clause 10.3 of the First Statues of IISERs	-	"In the event of the occurrence of any vacancy in the office of the Chairperson of Board of Governors by reason of expiry of his or her tenure, death, resignation or otherwise or in the event of the Chairperson being unable to discharge his or her functions owing to absence, illness or any other cause, the Chairperson of an Institute of National Importance (INI), may discharge the functions assigned to the Chairperson, for a period of six months or till the nomination of a regular Chairperson, whichever is earlier, with the approval of the Visitor.
