02	Typo Error in the EMD figure in the Check list	As per the tender document page no. 37 Check list for Bidder, "SCANNED COPY OF EMD OF ₹.1,00,000/- (ONE LAKH)" may be read as "SCANNED COPY OF EMD OF ₹.50,000/- (Fifty Thousand only)".
03	MSME exemption is applicable for EMD.	As per the tender document clause no. 5.1 under Earnest money Deposit details, bidders registered with MSME/ NSIC are exempted from payments of EMD and are required to submit the Bid Securing Declaration Form at Annexure IV.
