4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
5. The prescribed educational qualifications are the bare minimum, and mere possession of the same does not entitle candidates to be called for an interview. Where the number of applications received in response to this advertisement is large, it will not be convenient or possible to interview all the candidates.
