1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs

having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

Clarification, Technical Evaluation and Representation Clause

1. Right to Seek Clarification

The Technical Evaluation Committee (TEC) / Buyer reserves the absolute right to seek clarifications, supporting documents, explanations, or additional information from any bidder/service provider at any stage of the tendering process. Any clarification or document sought by the Institute through the GeM Portal shall form an integral part of the bid evaluation process. Compliance and submission of a complete, clear, and unambiguous response within the strict timeline prescribed on the GeM Portal shall be mandatory.

2. Consequences of Non-Compliance:

Failure to submit the required clarification, supporting documents, or information within the s

tipulated timeline; or the submission of incomplete, ambiguous, misleading, or unsatisfactory responses; or failure to comply with any requirement communicated through the GeM Portal shall render the bid liable for summary rejection. Such rejection shall be executed without any further notice, reminder, secondary opportunity, or correspondence for rectification. The bidder/service provider shall bear sole, exclusive, and unshared responsibility for ensuring the completeness and timely submission of all requested data.

3. Disclaimer of Liability for Technical/Systemic Failures:

The Institute shall not be held responsible or liable for any delay, technical glitch, server downtime, oversight, communication failure, non-monitoring of the GeM Portal, or any other omission or reason attributable to the bidder/service provider resulting in non-submission or delayed submission of clarifications. No request for extension of time, data modification, reconsideration, reopening of evaluation, or revival of a rejected bid shall be entertained on any such grounds.

4. Mandatory Mechanism for Representations/Grievances:

In the event of disqualification during Technical Evaluation, it shall be the sole responsibility of the bidder/service provider to regularly monitor the GeM Portal, review their evaluation status, and examine the reasons recorded for disqualification. Any representation, challenge, grievance, or objection regarding the evaluation outcome must be submitted strictly and exclusively through the designated workflow on the GeM Portal within the timeline prescribed by the system.

5. Estoppel and Waiver of Future Claims:

Failure by the bidder to submit a formal representation or challenge within the prescribed timeline on the GeM Portal shall be deemed as unconditional, absolute, and irrevocable acceptance of the Technical Evaluation outcome, findings, observations, and decisions of the Institute. The bidder/service provider shall thereafter be legally estopped from raising any claim, dispute, objection, grievance, administrative appeal, or demand for reconsideration in respect of the Technical Evaluation process or its outcome.

6. Exclusion of Alternate Channels of Communication:

Any representation, grievance, objection, or correspondence received after the expiry of the prescribed GeM timeline, or submitted through any mode other than the GeM Portal—including but not limited to email, physical letters, couriers, personal visits, telephonic communications, legal notices, or third-party interventions—shall be treated as non-existent (legally non-existent), summarily rejected, and shall not be entertained or responded to under any circumstances.

7. Finality of Decision:

Subject to the statutory provisions of law, the determination of the Institute/Technical Evaluation Committee regarding the adequacy, veracity, and sufficiency of clarifications, the responsiveness of the bid, and the technical qualification or disqualification of bidders shall be final, conclusive, and binding on all participating bidders/service providers.

Further, GeM reserves the right, at its sole discretion, to cancel

the bid forthwith, without issuance of any prior notice or intimation :-

2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
