Candidature shall be considered only upon production and verification of the prescribed certificates. Failure to produce the requisite certificates in the prescribed manner at the time of the Recruitment Selection Process shall result in cancellation of the provisional candidature, and such candidates shall not be permitted to participate further in the selection process. No request to submit certificates at a later stage shall be entertained under any circumstances.
