- 3) Candidates who are initially declared ineligible but are subsequently found eligible upon examination of their representation and supporting documentary evidence shall be included in the list of provisionally shortlisted candidates and shall be required to appear for the Recruitment Selection Process on the scheduled date.
- 4) Provisionally shortlisted candidates mentioned above shall produce the original Educational qualification and Experience Certificates, along with one set of self-attested photocopies, in support of their candidature at the time of the Recruitment Selection Process. Candidature shall be considered only upon production and verification of the prescribed certificates. Failure to produce the requisite certificates in the prescribed manner at the time of the Recruitment Selection Process shall result in cancellation of the provisional candidature, and such candidates shall not be permitted to participate further in the selection process. No request to submit certificates at a later stage shall be entertained under any circumstances.
