01	Eligibility Criteria	Core Institutional Experience The bidder should have successfully executed at least one continuous 12-month contract providing cafeteria, dining, food court, institutional catering, hostel mess, canteen, or allied food services during the last five (05) years in any one or more of the following establishments: a) Educational Institutions of National Importance such as IITs, IISERs, NITs, IIMs, AIIMS, Central Universities, or other Government-funded institutions; OR b) Reputed Corporate Campuses / IT Parks / Technology Parks / Manufacturing Facilities / Business Parks employing not less than 250 personnel at a single location; OR c) Public Sector Undertakings (PSUs), Research Institutions, Defence Establishments, Large Industrial Townships, SEZs, or Corporate Offices having centralized dining facilities. OR Large Commercial Establishments, Shopping Malls, Food Courts, Convention Centres, Airports, Railway Catering Units, or similar establishments having centralised food service facilities
