Bidders are advised to take note of this report while preparing and submitting their bids and to regularly monitor the designated procurement portals for any further official communication relating to the Tender.

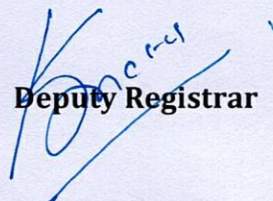
8. Final Declaration
