3. Recent passport-size photograph and photocopies of relevant certificates and other testimonials in support of age, qualification, experience, etc. will be collected at an appropriate stage.
4. The applicant will be responsible for the authenticity of all information and documents submitted, including photocopies of relevant certificates and other testimonials in support of age, qualification, experience, passport-size photograph, etc. It is the responsibility of the candidate to assess his/her own eligibility for the post(s) for which he/she is appearing, in accordance with this advertisement. If it is detected at any time in the future, during the process of selection or even after appointment, that the candidate was not eligible as per the prescribed eligibility criteria in this advertisement, and this could not be detected at the time of selection for whatsoever reason, his/her candidature/appointment shall be liable to be cancelled/terminated immediately.

GENERAL INFORMATION / DETAILS ABOUT THE POST

1. The appointment is purely temporary and will terminate automatically without any notice or compensation on the termination of the research project.
2. The appointed person shall have no claim of appointment/absorption in the Funding Agency or in IISER Tirupati.
3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project.
4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
5. Candidates should ensure that they have educational qualifications from recognized University/Institute and requisite experience, if any as on the closing date for submission of application. Those awaiting results of the final examination

for the prescribed educational qualification are not eligible and hence should not apply.

6. The prescribed educational qualifications are the bare minimum and mere possession of the same does not entitle candidates to be called for an interview. Where the number of applications received in response to this advertisement is large, it will not be convenient or possible to interview all the candidates. Based on the recommendations of the Screening Committee, the Project Leader may restrict the number of candidates for the interview to a reasonable limit after taking into consideration the qualifications and experience over and above the minimum prescribed in the advertisement. Therefore, it will be in the interest of the candidates, to mention all the qualifications and experience in the relevant field at the time of applying.
7. No TA/DA will be admissible for appearing for the interview.
8. The number of posts indicated may increase or decrease as per the Institute requirement.
9. Selected candidates will have to join duty immediately on receipt of the offer.
10. No interim enquiries/ correspondence/ communication of any sort will be entertained on the matter.
11. Canvassing in any form and/or bringing any influence, political, or otherwise, will be treated as a disqualification for the post applied for.
12. Candidates selected for this position can also apply for the regular PhD program of IISER Tirupati, provided they satisfy eligibility criteria.
